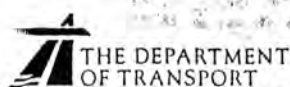
Notice is hereby given that the Secretary of State for Transport proposes to make an Order on the A604 and A1 Trunk Roads in Cambridgeshire.

The Order which is being made to enable resurfacing work to be carried out on the A604 exit slip road to the A1 southbound carriageway will be in force when the appropriate signs are erected from 3rd November 1992 until the works are completed. The work is expected to start on 10th November 1992 and will last approximately 2 weeks.

The effect of the Order will be to prohibit any vehicle from entering or proceeding in the A604 exit slip road to the A1 southbound carriageway and to impose a mandatory speed restriction of 30 miles per hour in the southbound carriageway of the A1 trunk road from a point 480 metres north of the A604 overbridge to a point 700 metres south of that overbridge.

The diversion route will be well sign posted. Any vehicle being used in connection with the said works, or for police, fire brigade or ambulance purposes will be exempt from the restrictions imposed during the works.
