**ENVIRONMENTAL PROTECTION ACT 1990 PART I: AUTHORISATION FOR
READY MIXED CONCRETE PROCESS**

Thank you for consulting the Health and Safety Executive about the above application submitted by Redland Readymix Limited.

The firm is within HSE's enforcement responsibility under the Health and Safety at Work etc Act 1974 and details of the application are noted for our records.

The ready mixed concrete batching process involves the use of, or may give rise to, substances likely to be subject to the (Control of Substances Hazardous to Health Regulations 1988 (COSHH)). Occupational exposure limits for a range of substances have been assigned under COSHH. Details of these standards are given in Guidance Note EH40/91, published by HMSO.

Authorisation conditions and any monitoring regimes to be required under the Environmental Protection Act should not contain requirements which could adversely affect the arrangements necessary to protect health and safety in the workplace.

The application for authorisation has not been assessed in detail but, if in your consideration of the application you identify any areas of potential confusion or conflict with health and safety at work issues, I would be pleased to discuss specific matters with you.

I suggest that the following text may be a useful reminder to the applicant and could be included in any covering letter sent with the authorisation. "This authorisation is given in relation to the requirements of Part I of the Environmental Protection Act 1990. It must not be taken to replace

any responsibilities you may have under workplace health and safety legislation".

When the authorisation is issued I would be glad to have a copy.
