Further to your letter of 23 Dec 04, (your Ref DOS/AJM/Q11Q2GSTPE/1), I confirm that we have taken the following steps to resolve this issue:

1. We have communicated the emissions data to the manufacturers and arranged a service visit.
2. Following service recommendations, we have overhauled the gas booster pump and replaced the sand.
3. The installation is now performing well and we are confident of improved emission performance.
4. I have issued an order for RPS to retest emissions as soon as possible.

I will contact you again once RPS have offered a test date.
