Pollution Prevention and Control Act, 1999 Environmental Permitting (England and Wales) Regulations 2010 as amended

When to use this form

This environmental permitting regime is known as and referred to as Local Authority Pollution Prevention and Control ('LAPPC'). Installations permitted under this regime are known as Part 'B' installations. Use this form if you already have a 'Part B' permit and wish to transfer the permit in whole or in part to another person ('the proposed transferee'). You may apply to transfer the whole or part of your permit. Under the Environmental Permitting (England and Wales) Regulations 2010 as amended ("the EP Regulations"), both the operator and the proposed transferee must jointly apply to have the permit transferred.
