Emission testing was being undertaken during inspection. Maintenance undertaken by plan
manufacturers, some minor issues indicated but nothing serious. Only a few (usually about 3)
employees operate the plant on a daily basis but more are trained. Operator uses manufacture
procedures to operate the plant. Company has ISO14001, the plant has shown a reduction in gas
usage as they cycle time is shorter.
