Comments

Dryer was running well below limit in permit. No "blue haze" could be seen off site. Slight odour could be detected but insignificant. Dust silo being upgraded and changes to the system to prevent shavings from escaping. Wood dust obtained from different suppliers but records kept of where and what is being burnt. Procedures and training undertaken and records kept. Maintenance system moving from electronic to paper. No environmental management system but they are looking into setting something up. Emission testing not undertaken yet but have been assured it will be booked in before end of financial year.
