Emission test for year 2013-14 not undertaken. No significant breakdowns on plant. Operator has

fully enclosed the conveyor from the chipper. No wood dust is brought onto site as only use pallets

which they chip themselves. Some changes to debarking unit planned which will make it easier to

clean (and quieter). Only new, relevant, personnel are the engineering manager (not completely

trained on environmental requirements of the site). Operator is moving towards electronic systems

for maintenance management and daily checks. 2014/15 emission test apparently undertaken on

07/07/14 and no submission of results (condition 21).
