Comments

Complaint received about smell of "gas" from the premise. No smell of gas could be detected in or out the building. The room with the dry cleaning machine had a typical smell of perc but could not be detected in other part of the building or outside. Operator thinks the smell came from a rug that was being cleaned as it smelt from animal urine and the first wash did not get the smell out. They had also hanged it outside to dry. No breaches of permit conditions could be attributed to the complaint.
