## Comments

Some changes to some extractor pipework (moved from underground to aboveground) but no permitting issues as a result. Reporting system being looked at and possible changes to company procedures but again no permitting issues. Small burners now fully exempt via the EA. A small amount of dust around wood dust storage unit (it was wet so not escaping off site). No issues with dust from working equipment and obviously cleaned regularly. Regular maintenance checks with both proactive and reactive repair undertaken. Company has ISO14001.
