Emissions monitoring is undertaken in February each year. Site has maintenance and monitoring procedures in place and records are kept of these. Most defects fixed by onsite personnel any larger defects usually fixed within 30 days. Majority of aggregate materials are kept in storage bays with a few under covers. Some more storage bays with covers being planned. Site is kept in a good state of cleanliness. Information readily available. Company operates to an ISO14001 standard.
