Comments

Two silo's on site for wood waste. Both have high level alarms and CCTV so operator can see any issues. The annual LEV testing checks the pressure differential and indicates any problems with the bag filters. Site re-bagged 2–3 years ago. Stated they usually last 5–8 years. The Permit states 4 years, however the company consider they are able to justify completing the works when required, as this has been the case for a number of years.

All procedures, training and maintenance records kept as previous. Company still has ISO14001.

Processes viewed, conditions discussed. No issues noted.
