Comments

Operator has installed a new system to completely control all maintenance, monitoring and

procedural systems. Every piece/section of equipment or procedure has an asset number which

information is kept which can identify when it was installed, maintained, calibrated, reviewed,

disposed, repaired or any relevant information for that asset. The system also notifies at least two

relevant people when action is required. The vents in the solvent area have been raised which

makes maintenance and monitoring easier. Carbon black is only used on 1 product and as up to

inspection date only been used on one run.
